You must be physically present in Victoria while participating in training and assessment. Skills First funding is limited to two courses at a time and only two courses in a year.

^{***}Fees concession is available for holders of a current Health Care Card (HCC) at the time of enrolment. Self identifies as an Aboriginal or Torres Strait Islander or works for an ACCO at the time of enrollment.

Can I get a refund?

- Ask a staff member

What happens if I can't pay my fees?

- You will have the opportunity to apply for a payment plan
- You will have the opportunity to apply for a pay/fee exemption (please asked RTO staff for further information)
- You may not receive your completed qualification documentation until full payment has been received although this is very unlikely as the first two options/opportunities are available.

Course cancellation or postponement


- Courses with low enrolments may be cancelled or postponed
- If the course is cancelled you will be given a full refund




Am I eligible for a government subsidised place?

You may be eligible for a government subsidised place under the Skills First. To be eligible you must be able to answer YES at each of the following steps.

What is RPL?

Recognition of Prior Learning or RPL is where you are assessed for part of, or an entire course based on your existing experience and skills. With support from a qualified Assessor you gather evidence to show that you already have the necessary skills and knowledge for the unit(s).

What is the fee for RPL?

Non-eligible student	The cost of RPL will be discussed and agreed with the RTO Manager prior to enrolment.	\$1000 minimum and \$2,500 maximum. Based on the amount of time taken to complete the RPL process. An assessment interview which takes a total of 4 hours will be \$1000.				

In the event of a student providing insufficient evidence for RPL to be granted the student may attend the relevant training and assessment program; additional fees will also apply. These fees will be determined by the RTO Manager and be agreed upon with the student at re-enrolment. This will involve the student re-enrolling.

Fee refunds for RPL

- If students wish to withdraw the RPL application before the planning interview they may be charged a \$30 administration fee and be given a full refund.
- If students wish to withdraw the RPL application after the planning interview, no refund will be given.

Fees for certificates

- Students are given their first certificate at no additional charge (testamur for a qualification or statement of attainment)
- Students who request a second or further copy of their certificate may be charged \$30 for each additional copy.
